RENEWAL ON OR AFTER OCTOBER 31, 2021

The Nevada Real Estate Division (NVRED) has updated the 36 hour CE Renewal Requirements. Real Estate Licenses that are to expire October 31, 2021 are required to submit 36 hours of continuing education. *(This does not apply to 1st Year Licensees who are required to attend Post Licensing)*

- Agents 65 years and older, with 30+ years as a real estate professional in the State of Nevada, with no pending disciplinary action, are only required to have 3 hours of Law, Agency, Contracts, and Ethics (3 hrs. Broker Mgmt and 9 hrs. of Property Management if holding Broker license and/or property management permit).
